# 1. The December PPG minutes were signed off

#### 2. Care Opinion feedback

RG summarized the feedback received over the last 11 months using our online feedback tool on the practice website called Care Opinion.

#### Positive feedback- 13 comments including:

- Felt listened to
- Friendly and caring
- Apologise when appropriate
- Pleasant nurse
- Excellent service

**Improvement needed- 4 comments**, which have been actioned and discussed within the practice to listen and learn:

- Experience at their smear test
- Not getting a reply to an email request

 An FP69 deduction and the patient was not aware they would be deducted by the NHS

# 3. Staff Update

The practice has a new practice pharmacist Mrs Din, who works 3 mornings a week as well as Ashish. We also have 2 new receptionists, who joined last summer.

The PPG fed back that they had had a positive experience when having consultations with the additional practice staff such as the pharmacist and first contact physio.

# 4. PCN update

RG updated that as well as extra in house services within our PCN patients are also able to access other services at community pharmacies, a local optician and other local GP surgeries.

- Community pharmacy consultation service- the practice staff will navigate suitable patients to this service and the pharmacist normally contacts the patient the same day and notifies the GP of the outcome by email which is added to the patient record
- Minor Eye service- patients can book at Rose optician on 0208 985 1971 for common eye conditions which are not an eye emergency.
- Community pharmacies can offer a BP check and 24 hour BP check, if referred by the GP
- Social prescribing and care coordination also bookable at the practice
- Extended hours appointments for GP, nurse and HCA appointments at local surgeries also in E5
